She was worried that underage students may gain access to this alcohol. Ms. Lachow hoped that the Board, Administration and community would support her in opposing this proposal and join her at a rally scheduled for that Saturday. Additionally, Ms. Lachow, spoke about the Holiday Adopt a Family Program, which she co-chairs with Ms. Interdonato. She reported that there has been an outpouring of support from both within and outside the community, and because of this they were able to provide much needed gifts to 177 members of the community. Ms. Lachow thanked the Board of Education for allowing them to run the program and to everyone who participated for their kindness and generosity.
