II. ANNOUNCEMENTS

Ms. Rifkin stated that she had previously reported on Gardiners Avenue being cited as a LAP School. She explained that this is a school in need of improvement based on the gap between the scores on the state assessments and special education population scores on the state assessments. She reported that the district had to put together an extensive plan that had many measures. Ms. Rifkin was happy to report that based on results of the assessments, Gardiners Avenue is no longer a LAP school. Dr. McDonald thanked Ms. Rifkin and the administration for all their hard work to remove that designation.

Ms. Marenghi shared with the Board and audience a personal matter. She stated that her daughter-in-law has worked for the district for the past three years, as a CSR teacher and as a long term leave replacement. Last year her daughter-in-law was hired by the Board of Education as a probationary special education teacher with a unanimous vote of approval. Last month her name was placed on the agenda for a special education summer school position. Ms. Marenghi noted that the Board knows her daughter-in-law's name. She reported that there were comments in the community that she was doing something sneaky and backhanded and trying to get her daughter-in-law slipped onto the agenda. She remarked that the Board does not put names on the agenda that is done by the Superintendent. Ms. Marenghi is addressing this issue personally because she feels it is a direct attack on her character which is based on integrity. She noted that having been in the field of education for 32 years, she has made many mistakes which she always tries to rectify. She feels no mistake was made in this case.
