Ms. Rifkin announced that several students would be honored as a result of their high PSAT scores through the 2014 National Merit Scholarship Program. The principals of the two high schools, Mr. Sheehan and Ms. Lorelli, introduced their students. The Board congratulated the students and they were presented with certificates.

Ms Marenghi acknowledged the beautiful art work in the Board Room and hallway from Abbey Lane. She remarked it is always wonderful to see.

# B. Superintendent

### 1. Comments and Reports

# **APPR Hardship Waiver**

Ms. Rifkin informed everyone that New York State came out with new regulations for Annual Professional Performance Review (APPR) governed by Education Law § 3012-d. School districts that fail to have an approved plan in place by November 15, 2015 will not be eligible to receive increased State funding. This law simplifies the APPR structure but gives Districts less discretion in the formulation of plans. Ms Rifkin explained that she met with her Committee early in the summer to discuss and negotiate some of the changes that were presented. She went over some of the key changes to this new law. However, being that it was summer it was difficult to get everyone together until the first day of school, therefore a completed plan is not in place yet. The State has informed Districts that if no plan is in place by October 1st, they can apply for a hardship waiver. This would keep us for now on the old regulations until a new plan is approved. She mentioned that every district in Nassau County is applying for this waiver. Ms. Rifkin described some of the key pieces of information the State is asking us to obtain for this waiver. Dr. McDonald shared that the committee has had meaningful discussions because eventually this is going to happen. She remarked that it was unfair of the State to ask any district to develop this plan over the summer. It was difficult to do over such a short amount of time. Ms. Rifkin advised that we have every intention of coming up with a plan to ensure that we have a fair system for our teachers and principals. She noted that this plan would be in place by the beginning of the next school year.

#### **Food Service Committee**

Mr. Pastore shared that we have had a food service committee for several years and they do a great job. He mentioned that these are dedicated people who come out once a month and visit the schools. He noted that the terms of the Committee members is limited to three years based on Board guidelines unless an exemption is given. He advised that it has been a problem recruiting new members. Mr. Pastore stated that the individuals listed on the agenda for approval have been on the committee previously. He remarked that we need to discuss whether we can have members exceed the three year limit. Ms. Quinones-Smith asked if students can join. Mr. Pastore responded that the current committee includes students but we can give them a bigger role. Mr. Ward advised that it is difficult to staff that committee and if someone wants to continue on the committee it doesn't hurt us. Mr. Pappas asked if the PTA could seek out new members. Ms. List, PTA Council President, was asked for a point of information. She remarked that it is hard to find parents that are available to volunteer on a regular bases. She feels the food service committee is an extremely important one. It is the eyes and ears of what goes on in the cafeteria. Ms. List noted that in recent years the high schools students on the committee have been a wealth of information and a huge resource for us. She pointed out that it is nice to have people on the committee that have been there a few years because they then have background knowledge. She would hate to discourage anyone who wants to volunteer. Ms. Marenghi had questions on the role of the volunteers. Ms. List explained that students know the parent volunteers and feel they are approachable with any concerns. Mr. Pappas remarked that the volunteers are more like independent observers.

### **Long Island Consortium for Excellence and Equity (LICEE)**

Ms. Rifkin stated that Levittown has been asked to participate in this Consortium. She explained that this Association is made up of districts across Long Island that meet monthly for very high quality professional development provided by the University of Pennsylvania School of Education. Dr. McDonald pointed-out that we are very proud to be counted among the very best performing districts on Long Island. She shared that the training is free and our teachers can then turnkey it.

### **Assistant Basketball Coaches -helmets**

Dr. McDonald advised that she had received several requests from parents to have assistant basketball coaches. She asked Mr. Snyder, Director of Physical Education, to discuss this with the Board. Mr. Snyder noted that at one time there had been assistant coaches but they were eliminated during a budget crunch. He feels it is now time to have them reinstated. Mr. Snyder explained how the process works for Varsity and Junior Varsity (JV) coaches. He stated that in a Varsity game the JV coach assumes the assistant coach position with no compensation. Games are usually played back to back. Mr. Snyder stated that it puts a lot of undo pressure on the JV coach. In the case of a student injury, the Varsity coach stays with the injured student while the JV coach stays with the game. If a JV coach is not at the game, the game would end. Mr. Snyder advised that assistant coaches bring rudiments and basics to the game. They enhance team play with more hands on deck. In assessing surrounding districts, Mr. Snyder reported that eight districts have assistant coaches while nine do not. He stated that the assistant coaches would be just on the Varsity level for four teams, both boys and girls. Mr. Pappas asked what other teams on the Varsity level do not have assistant coaches. Mr. Snyder responded only basketball and volleyball. Mr. Pappas asked why he wasn't asking for assistant coaches for the volleyball teams. Mr. Snyder remarked that volleyball is a non-contact sport. Mr. Pappas noted that the Board policy does not distinguish between contact and non-contact sports, just the number of players on a team. Ms. Marenghi was shocked to find out that we did not have assistant coaches on the basketball teams. She asked for backup data on student injuries on the basketball and volleyball teams. Ms. Adrian suggested that we put something about contact sport vs. non-contact sport in our policy. Mr. Pappas asked if we could add stipends to the JV coaches pay. Dr. McDonald felt that assistant coaches could be helping out at practices. Mr. Snyder remarked that the more adults supervisors and coaches that work with our children, the more the team benefits. The consensus of the Board was to amend our guidelines to include wording about contact sports. Dr. McDonald suggested that Mr. Snyder look at his numbers at budget time to see what can be adjusted to include assistant coaches for basketball. Additionally, Mr. Snyder had football helmets on display from current to previous years. He noted that Newsday had recently posted a report on football helmets which he felt was a flawed study. Mr. Snyder passed around data on football helmet safety ratings. Mr. Snyder went on the discuss the report. He noted that we have had very few students with concussions. He feels this is due not just to the helmets used but also to the way our athletes are coached using proper tackling techniques. Dr. McDonald stressed that the helmets we use are certified safe. Mr. Pappas thanked Mr. Snyder for a doing a great job.

### **Citizens Advisory Committee on Budget (CAC)**

Mr. Pastore reported that there were only three volunteers for the Committee and the Board guidelines say you need at least ten community members. Mr. Pappas stated his opinion that you should have the Committee even if you only have a few people. He noted that you give them only one area to focus on. Ms. Marenghi commented that we set guidelines so that the Committee could be effective and we should adhere to them. There was a discussion on this issue. It was decided by consensus that the Budget Committee would not run this year but be offered again next year. Dr. McDonald stated that she would reach out to the individuals on the list to let them know that we will sit down with them and answer any questions or concerns they have.

### **Districtwide Security**

Mr. Pastore provided information on our security force. He noted that we have open shifts in the late night and early morning hours, especially for the weekends. He commented that his staff was working on ways to fill these shifts because it was becoming very difficult to staff the overnight shifts. Ms. Marenghi asked what was the pay structure for these hours. Mr. Pastore explained that we have ten month and twelve month security employees along with part-timers. The rate for the part-timers is significantly less than for full-time employees. Dr. McDonald commented that the plan is to come back to the Board at the next meeting with a recommendation on how to deal with this issue moving forward. Mr. Pastore thanked Mr. Carroll, Mr. Milano and all of the security staff who spend all their time protecting us and watching over the district's assets. They do a great job.

### **Weighting of Regents Exams**

Ms. Rifkin announced that the district will not be having a mid-term week. School will continue as usual for high schools. She noted that there will be quarterly assessments in some classes that count as a test grade. In the past, there were six grades weighed as one sixth to determine the final grade for the student. Since we will no longer have the mid-term grade, the thought was to have each test count as 20%. She stated this creates a problem because of some new tests being given. Ms. Rifkin shared that several districts will be devaluing the weight of the Regents Exam in the student's final average. She noted that our recommendation is to change the weighting of the Regents to 10% and divide the other 90% so that it comes out to 22.5% per quarter for the four quarters. Dr. McDonald shared that many districts will be implementing the State's recommendation that the Regents exam not be counted at all in the student's final average or assessing on a student by student bases which she feels is unethical. She stated that our proposal of 10%, makes the Regents count for something and won't hurt the student. Dr. McDonald asked for feedback from the Board. Ms. Marenghi commented that using scores on a person by person basis is not a fair playing field. Her personal opinion is that the 10% weighting can't hurt and may even help the student, it is more meaningful. Dr. McDonald remarked that what gives you success in this world is hard work and what shows students hard work, is their quarter averages and how much they do during the year. Mr. Pappas stated that we hired Dr. McDonald to run the district and if this is her opinion than I am on board. The consensus of the Board was to move forward.

### **PSEG (LIPA)**

Mr. Pastore wanted to make everyone aware of a recent change made by Nassau County for PSEG. This change was supposedly made so that PSEG would not raise their rates to the homeowners. He reported that they moved from a Class 4 Commercial Property to a Pilot (payment in lieu of taxes) Program. Mr. Pastore explained the differences in the classes for Adjusted Base Proportions and Assessments. Dr. McDonald noted that Nassau County has increased the amount that single family homes will pay by 1.13913%. Mr. Pastore remarked that Utility Companies will pay less of the tax burden this year. Mr. Cohen, legal advisor, shared that the County is considering allowing Utilities to pay their Pilot over time or make partial payments. This decision might affect school districts in that you might get less money in the beginning of the year so that you would have to go out for Tax Anticipation Notes (TANS). These TANS are like bridge loans to use while you wait for your tax revenues. Dr. McDonald explained that the district only has a few major sources of revenue, such as State Aid and taxes. This money does not come in right away but we always have payroll to meet. She commented that Levittown is very fortunate in the we have not had to go out for TANS for a very long time. Additionally, Mr. Cohen remarked that this change could impact next year's calculation of our tax levy cap. Dr. McDonald advised that the district would continue to update the community on this issue.

# 1. Comments and Reports

New York State School Boards Association (NYSSBA)

Ms. Adrian discussed the recommendations of the Resolutions Committee on proposed resolutions which will be acted upon by the delegates at the NYSSBA Annual Business Meeting on Tuesday, October 20, 2015. Dr. McDonald explained the process which was that the Board can choose to accept these recommendations and charge our Board voting delegate to vote that way or go over each amendment individually and vote for what NYSSBA says or against. Ms. Adrian reviewed several of the resolutions that she felt had the most discussion at a recent meeting. The Board talked about these resolutions and how to vote. Ms. Marenghi thanked Ms. Adrian for her participation at the NYSSBA meetings.

### 2. Correspondence

### 3. Student Liaisons

Mr. Lunetta shared that Division Avenue had a very exciting Homecoming this year with perfect weather. The highlight of the day was the Dragons victory over North Shore. He reported the following: three talented musicians have been selected to perform at the Long Island String Festival Association Annual Conference Concert; six seniors placed among top five percent of more than 1.5 million students who took the 2014 PSAT Qualifying Test; the JV and Varsity Girls Volleyball teams will be holding their Annual Dig Pink Fundraiser and games this week; the marching band won 2<sup>nd</sup> place in the competition at Huntington High School; and our athletic programs are doing very well.

Mr. Thind announced that all of MacArthur's ninth graders received their tablets and training on how to use them from Microsoft representatives and our IT Department. He commented that MacArthur's pep rally and homecoming was a huge success. Mr. Thind remarked that the mini-college fair was very informative with valuable information obtained from over thirty colleges. MacArthur students also performed at the Long Island String Festival Association.

Mr. Pappas questioned some of the comments on the contracts from the plan. There was discussion on this subject. Mr. Pastore stated that the auditors want the districts to have the contracts completed on a timely bases, prior to the billing. Mr. Cohen, legal advisor, explained that there are many different contracts. The contracts for special education services and health and service are pretty much boiler plate with very little change. The contracts with private providers are more highly negotiated and have different provisions. Mr. Cohen noted that certain language was put into the contracts to protect the district

because contracts that are for the expenditure of money are not valid until the Board of Education approves them. Mr. Pappas asked about the charges for the outside use of facilities. Mr. Pastore explained that the auditors want to make sure that the district recoups all of the overtime charges. Lastly, Mr. Pappas wanted to know how the credit memos are being handled. Mr. Pastore noted that this is an internal control issue and the auditors wanted to make sure that we have segregated the duties. There was a discussion on this issue.

Mr. Buchys suggested we get a particular actress to speak to our students.

### Jane Finkelstein 848 Mayer Drive, Wantagh, NY

Ms. Finkelstein thanked Dr. McDonald for signing a petition petitioning Congress to abolish the requirement for annual testing of students in grades three to eight. On another note, she wanted to speak about the Algebra Regents. She reported that other districts have decided to only teach Algebra II/Trigonometry and opposed to the CC Algebra. Ms. Finkelstein went on to discuss this issue. She advised that she was unable to find a tutor for her son for this Regents. She feels this is because teachers do not feel comfortable to tutor this class because they are not confident in the coursework. Ms. Finkelstein remarked that there is confusion as to which Regents will be given. She would appreciate any information on this topic. Additionally, Ms. Finkelstein wanted to discuss the inequities in the grading policy within the district in terms of what teachers offer their class to succeed. She feels that for every student to succeed they need to have the same opportunity and not disparity. Ms. Finkelstein stated that the self-esteem for the Class of 2017 has been damaged.

### **RESPONSE:**

Regarding the Regents, Dr. McDonald commented that Ms. Rifkin has been doing a lot of research on this subject. Ms. Rifkin explained that our teachers are in the process of teaching Algebra II Common Core. She noted it is our intention of giving both. She commented that we are trying to gather as much information as possible to figure out what is best for our students. Ms. Rifkin stated that we need to make sure our students are prepared. Dr. McDonald remarked that the State has neglected to include certain topics we need to move forward.
