#### A. Student Presentations

#### 1. Musical Presentation: MacArthur Winter Wind Ensemble

Ms. Marenghi thanked the musicians, who performed holiday music in the auditorium, for a wonderful enjoyable performance.

# 2. Student Art Display: Wisdom Lane School

Ms. Marenghi acknowledged the beautiful art work adorning the Board room and hallway.

#### 3. Student Presentation: Wisdom Lane School – "The Memory Project"

Mr. Avena, Principal of Wisdom Lane Middle School, introduced Ms. Herbert who was responsible for initiating this project. She called on the students from her Studio Art class to explain this project. The Memory Project is a non-profit organization that invites art teachers and their students to create portraits for youth around the world who have faced substantial challenges in their life. These portraits bring happiness and keepsakes to children who are less fortunate. A short video was shown. Ms. Herbert remarked that we are teaching curriculum and also doing something great for humanity. She thanked the Board and Central Office for their support. Dr. McDonald commented she was looking forward to viewing the video of the completed portraits.

# B. Recognition

#### 1. Student Recognition – Outstanding Fall Athletes

Dr. McDonald spoke about how proud she was of these remarkable athletes. She introduced Mr. Snyder, Director of Physical Education, Athletics Health and Health Services, who introduced the students who were to be honored tonight for their achievements in Fall sports. He thanked all the coaches for a great job and the parents for all their support from home.

# C. Superintendent

# 1. Comments and Reports

#### a. Coke-Cola Semi Finalist

Dr. McDonald remarked that she was very happy to announce that Division Avenue had a Coke-Cola Semi Finalist which is a huge competition. Ms. Rifkin explained that this award is a scholarship based on academics and leadership. She commented that it is very competitive with significant monetary awards.

#### **b.** Memorial Mass

Dr. McDonald shared that there would be an Ecumenical Memorial Service at St. Bernards for those individuals who worked for the district. She noted Mr. Regan would be included in their prayers.

# c. Every Student Succeeds Act (ESSA)

Dr. McDonald reported that the President will be signing a new bill which replaces the No Child Left Behind Act. She stated this bill takes away the control from the Federal government and gives it back to the State.

# d. Vending Machine Report

At the last meeting, the Board had requested a report on our vending machines. Mr. Pastore handed out a report which included three years of data on the history, amount and income of the vending machines. He noted that research was being done on "Scholars for Dollars" and that a bid would be sent out in February for next year.

#### e. Tax Cap Legislation

Dr. McDonald remarked that she wanted everyone to be aware that the tax cap legislation had a piece in it that affects income tax. She asked Mr. Pastore to explain. He reported that this is part of the New York State Tax Law that allows for a refund of state taxes. There are three stipulations: the person receiving the refund has to be a resident, has to own property that gets a star exemption and has to earn less than \$275,000. Additionally, the school district cannot pierce the tax cap. Dr. McDonald commented that the district has no plans to pierce the cap so our residents will receive this refund provided they meet the other criteria.

Mr. Lunetta, Student Liaison, reported on some of the achievements from the students at Division Avenue: two students from a Digital Media Class had their films screened at the Gold Coast International Film Festival; the Lady Dragons Soccer Team captured the conference title; six senior athletes have signed National Letters of Intent to continue their sport at the college level; the Class of 2016's 35 top achievers attended the Blue and Silver Luncheon; the Art Club and National Art Society held a fund raiser to fight against breast cancer and raised \$400; before Thanksgiving, the annual food drive was held and collected an unbelievable amount of food for families in Levittown; the PTA sponsored an amazing and inspiring assembly led by Rohan Murphy, and the Varsity Cheerleaders competed in the UCA Cheerleading competition and placed 7<sup>th</sup> out of 25 teams which earned them a chance to compete at Disney.

Mr. Thind, Student Liaison for MacArthur, reported on the events at his school: a new entrant breakfast for students new to the school was held; an emergency shelter drill was conducted; the play "Legally Blonde" was performed to a packed house; quarterly exams were administered; there was a very informative Financial Aid Night; the teachers held a Teacher's Choice Breakfast as their way of recognizing a student who has engaged in not only positive classroom behavior but also exhibits positive character outside of the classroom; several students were excepted into the Long Island String Festival Association; the Varsity Football Team won the 2015 Nassau County Varsity Football Conference II Title.

#### 1. First Read

# Policy No. 3420 - Non-Discrimination and Anti-Harassment in the School District

Ms. Rhatigan noted some of the changes to the our current policy such as the definition of harassment and modifying the number of individuals serving as Civil Rights Compliance Officers from two to one.

# **Policy No. 5675 - Student Grading Information Systems**

Dr. McDonald explained this is a new required policy from Erie I BOCES that addresses the Comptroller's specific areas of concern: tracking and monitoring user activity, audit log functionality, and reasons for and documentation supporting grade changes. She noted changes were made to the policy to tailor it to our district. Ms. Rhatigan further explained that this policy helps districts maintain student data integrity by limiting access to only authorized users. Districts will further protect the data by making users' system permissions compatible with their roles and job duties.

# Policy No. 6120 - Equal Employment Opportunity

Ms. Rhatigan noted that the procedures for Investigation of Complaints and Grievances was added to the policy as well as modifying the number of individuals serving as Civil Rights Compliance Officers from two to one.

# Policy No. 6121 - Sexual Harassment of District Personnel

Ms. Rhatigan remarked that this policy talks specifically about the definition of sexual harassment and outlines prohibited conduct which was not in our previous policies. Additionally, it modifies the number of individuals serving as Civil Rights Compliance Officers from two to one.

#### 2. Second Read

# Policy No. 3110 - Media/Municipal Governments/Senior Citizens

Dr. McDonald reported that while redoing the Facilities Policies (#3280) a piece on Senior Citizens was discovered. It was deleted from that policy and included in Policy #3110. She remarked no changes were made from the first read.

#### Policy No. 3280 - Use of School Facilities, Materials and Equipment

Dr. McDonald noted the changes discussed regarding the rates were included in this read.

# Policy No. 7131 - Education of Homeless Children and Youth

Dr. Sturz reported that the State Education Department had requested that districts address the 50-mile limit on transportation of homeless children. They recommended inserting a sentence to that effect to the policy.
