I. CALL TO ORDER

- A. Mr. Moran, President, called the Regular Board Meeting to order at 6:30 PM. On a motion by Ms. Adrian, seconded by Ms. Marenghi and approved (5-0) that the Board adjourn to Executive Session for the purpose of a disciplinary matter involving a particular student.
- B. The Board reconvened to Public Session at 7:35 PM on a motion by Ms. Lang seconded by Ms. Adrian and approved (5-0). Mr. Moran asked everyone to stand for the Pledge of Allegiance which was led by Julianne Magliano from Salk Middle School. Mr. Moran requested a moment of silence for our armed services here and overseas protecting us.

II. REPORTS

A. Student Presentations

Student Academic Presentation – Salk Middle School Virtual Field Trip

Mr. Winch introduced the faculty, Administration and students from Salk Middle School who were here tonight to talk about Virtual Field Trips. Mr. Zampaglione, Principal of Salk, thanked everyone for coming out to show their support. Ms. Anderson and Ms. Joshuakutty gave a brief description of Video Conferencing and noted that this is a tool to increase the use of technology in education. The potential benefits for students are endless. Ms. Anderson noted that 200 students participated in eight free Virtual Field Trips that were conducted. The teachers thanked Mr. Connell and the Tech Department for all their help.

Science Standouts Recognition

Mr. McDermott, Science Director, spoke about the Science Program at Levittown and welcomed the district's top science students who were honored for their accomplishments throughout the 2016-17 school year. Skills USA Winners

Mr. Creter, Director of GC Tech, talked about the organization. He noted that SkillsUSA provides educational programs, events and competitions to support career and technical education in the nation's classrooms. Ms. Emeric, Coordinator of Skills USA, spoke about the students achievements. She noted that four students medaled during the New York State competition held in Syracuse, NY. The students were congratulated, and the parents were thanked for their support.

Music and Dance Student Standouts

Mr. D'Ulisse, Curriculum Associate for Music, thanked the Board of Education and Administration for acknowledging those students who have excelled in all phases of the music program. These selectees were given certificates of merit for their participation the in the Long Island String Festival, All County, All State and All National Music Awards. The Board congratulated these talented students.

Staff Tenure Recognition

Ms. Rifkin commented that tonight we spent time honoring our wonderful students and without our wonderful teachers those accomplishments would not be possible. She remarked that we will be honoring some of our relatively new teachers that received tenure at the last Board meeting. The Principals of each building were called up to introduce the recepients and give a brief highlight of their career. The Board congratulated them all.
