I. CALL TO ORDER

- A. Mr. Cain, Vice President, called the Regular Board Meeting to order at 6:30 PM. On a motion by Ms. Messina, seconded by Ms. Lang and approved (4-0) that the Board adjourn to Executive Session for the purpose of seeking legal advice from the Board's Attorney.
- **B.** The Board reconvened to Public Session at 7:35 PM on a motion by Ms. Adrian seconded by Ms. Lang and approved (4-0). Mr. Cain asked everyone to stand for the Pledge of Allegiance which was led by the High School Student Liaisons. Mr. Cain also requested a moment of silence for all those serving our country at home and abroad and also for all the victims and the people who served us so well on 9/11.

II. REPORTS

A. Recognition

i. Art Display - East Broadway School

Dr. McDonald acknowledged the wonderful artwork in the Board Room and hallways. She commented that she finds it amazing that it is done by elementary students.

B. Superintendent

1. Comments and Reports

A. Budget Transfers - ESSA

Dr. Dillon shared that after collaborating with other Districts and seeing their practices and with the new ESSA requirements, in terms of breaking down our costs per building as opposed to a District wide level, it seems a lot of Districts are updating their policy in terms of transfers. He noted that on tonight's Agenda is a Motion to allow us to transfer salary codes without waiting for a Board Meeting for approval. He explained that as of now all salary codes are broken out amongst the ten buildings. This change in practice is more manageable for accounting purposes and streamlines the process for efficiency. Dr. Dillon noted that it is not taking away the approval of a transfer but allowing us to transfer salary money without waiting for Agenda approval. A report will still be provided to the Board on a monthly basis with all the Treasurer Reports, normal non-salary transfers (ST3) and will follow the \$10,000 approval. Dr. McDonald clarified that we are only talking about salary codes to salary codes. She explained that this is because the ESSA regulations require us to budget salaries by school. Mr. Cohen, Legal Counsel, commented that it will still be reported, and you will see it in the financial documents and reports you receive every month.

2. Follow-up to Prior Public Be Heard Questions

Dr. McDonald read a response letter to a parent at the last Board Meeting who had requested the Board put a temporary hold on the law that was recently passed prohibiting children with religious exemptions from attending public school until the case is litigated. The letter stated that since the Board Meeting, Judge Hartmann has rendered a decision denying the preliminary injunction; and New York State has issued additional guidance further restricting the Districts' flexibility in these matters. Thereby, students who are not vaccinated may not attend public schools in New York unless they meet the requirements from the Department of Health.

3. Student Liaisons

The Principals from both High School introduced the Students Liaisons for this school year and spoke about their achievements.

Emily Fuchs, the student representative from Division Avenue High School, reported on the notable events during the summer and the first week of school: Freshman Orientation was a great success with students introduced to administration and staff and shown a video featuring seniors promoting the clubs and sports offered; the school was recently designated a 2018-2019 Recognition School for high achievement and high progress; the number of AP Scholars with Honors and AP Scholars with Distinction as well as students earning an AP Capstone Diploma has grown tremendously; the Cheerleaders hosted the 3rd annual Cheer Camp; the Guidance Department sponsored a college mini fair and all students are happy with the new bathrooms in the gym lobby.

Student Liaison, Caroline Johnson shared the events at MacArthur High School: two students carried out science research projects at the Brookhaven National Laboratory; close to 200 parents attended the Freshman Parent Orientation Meeting and found it very worthwhile and rewarding; the first day of school was extremely successful and the brand new parking lots have been well received; a successful college mini fair was recently conducted; upcoming events include Back to School Night and our Annual Homecoming .
