VIA VIDEO CONFERENCE

I. CALL TO ORDER

- A. Ms. Marenghi, President, called the Regular Board Meeting to order at 6:30 PM. She asked everyone to stand for the Pledge of Allegiance and requested a moment of silence for all those serving our country at home and abroad. On a motion by Mr. Pappas, seconded by Ms. Adrian and approved (6-0) that the Board adjourn to Executive Session for the purpose of seeking legal advice from the Board's Attorney.
- **B.** The Board reconvened to Public Session at 7:38 on a motion by Ms. Lang seconded by Ms. Adrian and approved (7-0).

II. REPORTS

A. Superintendent

1. Comments and Reports

Dr. McDonald asked Mr. Winch to present his powerpoint presentation titled Schools Reopening Update. He pointed out that this was the third presentation on our reopening plans for the fall. He reviewed the next steps in the reopening process which are organizing our facilities; open parent forums; transportation and health screenings. Mr. Winch reported on the plans for September on the Elementary level where all students will be eligible to attend school every day; the Secondary level where students will attend in a hybrid model; and those who choose a full remote option. Additionally, he discussed what would happen if all schools are closed due to COVID-19. He shared information on testing and tracing; health protocols; face covering protocols; and cleaning protocols along with kindergarten screening; athletics; LAP and LAMP; extracurricular activities; and mental health plan. Mr. Winch stated that we are a work in progress, and we have many challenges to address as we work to reopen our schools. He noted that changes may occur during this process, and we appreciate your patience. He noted that the District website is a great resource for parents especially the Frequently Asked Questions page. Dr. McDonald asked Mr. Winch if we were required to provide a remote option for students. Mr. Winch responded that New York State requires Districts to provide an option for students who are medically fragile but there is no specific language that indicates that we must provide a remote option for anyone that wants it. Mr. Cohen agreed with Mr. Winch's response.

Ms. Marenghi shared that they confirmed all the protocols put out by the Governor's Office were being followed. She thanked Chris Milano, the custodians and everyone who worked so hard to have the buildings ready for September. Mr. Pappas remarked that after seeing all the uniform and adaptive safety protocols put in place in the buildings, his mind was at ease regarding reopening. He noted that he particularly liked the increased outdoor learning opportunities. He thanked everyone for a good job.
