**Sr. Award** – Linda reports that the application is on website and deadline is May 1<sup>st</sup>. Forms are available at the Guidance office.

Staff Appreciation – The event takes place in May. We need a chairperson for this.

**Plant Sale** – Flyers are being prepared for the spring sale. Prices will remain the same as last year and we will be using the same company.

## Liaison Reports:

**Council Budget** - The committee presented to Council on 2/26 and it was voted on to be presented to the BOE on 3/11.

**Secondary Curriculum** – Mary Rickard reported meetings were held on 1/22 and 2/11. There was discussion on the criteria to be placed in an Honors class.  $6^{th}$  grade going into  $7^{th}$ , a rubric is used. ELA or Math test,  $3^{rd}$  quarter average and teacher recommendation are all used to determine eligibility. To remain in honors students must have a greater than a 65 average at the end of the first quarter, greater than a 75 average at the end of the  $2^{nd}$  quarter and a final average of 85 or higher. Catalyst is an ACT prep program. It will take place over a weekend, 4 hours a day. The cost will be approx. \$160 per student. Changes have been made to the phys ed paper. The topics were redesigned and a grading rubric was provided. The next meeting will be 3/23.

**Elementary Curriculum** – Mary Rickard reported that the meeting was held on 2/11 jointly with secondary curriculum. Kerin Slattery, the new English curriculum associate was in attendance. She presented some of the shifts in ELA and Literacy including: balancing informational and literacy text, building knowledge in all disciplines, staircase of complexity, text based answers, writing from sources and academic vocabulary. Students will continue to do text rendering in order to develop the skills necessary to succeed with this shift. The next meeting will be 3/14.

**Food service** – Pat Genco reports the quality control checklists from each school. Some issues brought up were: a refrigerator is down waiting for a compressor, tacos were cold, children are discarding fruits and vegetables, children like the popcorn chicken but not eating the larger chicken nuggets, eggs are watery, Bosco sticks are a big hit, water stations are great and some units are not sending representatives. The next meeting is 3/18.

**Health and Safety** - The meeting was held on 1/29/15. Most schools need their speedbumps repainted. Summit needs speedbumps. Pick up and drop off of students were discussed. There were talks of setting up an anonymous tip line for middle and high school students to be able to report things without the fear of others knowing. Lunch personnel were offered a free training in CPR and first aid. There are procedures in place regarding children with allergies.

**New Business** – Levittown Council and Wisdom Lane Scholarship applications are now online. Division Avenue Lacrosse blankets are on sale for \$40.00.
