A MESSAGE FROM THE BOARD OF EDUCATION... Preserving and Enhancing Programs Within the Tax Levy Cap

The Levittown Board of Education is cognizant of rising property taxes and remains steadfast in its commitment to limit the tax burden on the community. Through careful and resourceful planning and a collaborative effort with Central Administration, the Board has proposed a 2016-2017 budget totaling \$205,449,470 that keeps rising costs minimal while preserving and enhancing key instructional and co-curricular programs for students.

The state's tax levy cap that was set to expire in 2016-2017 has been extended to 2019-2020, resulting in the district's preparation of a school budget with limits under New York State's tax levy cap law. All New York State school districts are provided with the same formula to calculate the district's highest allowable tax levy, which still requires a simple majority of voters (50 percent plus 1) to pass.

In preparing the 2016-2017 budget, the Board elected to adopt a tax levy increase of 0.84 percent, which is at the allowable tax levy cap as per state law and which realizes a budget-to-budget increase of 1.8 percent. This proposed spending plan maintains and enhances current instructional and co-curricular programs, including the one-to-one tablet initiative, curriculum aligned with the New York State Common Core Standards, refreshed technology and the purchase of school buses. It also includes adoption of the College Board's AP Capstone program, the implementation of robotics classes and enhancement of the middle school's computer literature classes. In addition to the district's proposed budget, the community will be asked to approve a second proposition to allow the district to expend \$4 million from the capital reserve fund, previously established by voters, to undertake and perform school district improvement projects. These projects will include districtwide improvements to the electrical systems and masonry. The capital reserve has been used to fund projects such as renovations to the weight and locker rooms at Division Avenue High School and Salk Middle School, as well as cooling stations throughout the district. *The expenditure of funds from the capital reserve fund has no impact on the tax levy.*

Student achievement continues to bring pride to the Levittown community. Page 2 of this brochure contains information on many of our students' educational and co-curricular accolades, as well as the special spring edition of the Leader, which is insert into the pages of this budget brochure. Please continue to visit the district website at www.levittownschools.com to read about student achievement and various activities throughout the school year.

We encourage you to become familiar with the proposed budget and capital reserve expenditures highlighted in this newsletter, as well as information on voting locations and times, voting qualifications, absentee ballots and budget hearing information. In addition, we encourage the community to take time to review the budget presentations posted on the district website and to attend the budget hearing on Wednesday, May 4 at 7:30 p.m. at Levittown Memorial Education Center.



EDUCATIONAL DOLLARS AT WORK

COMMUNITY:

- Special high school musical performances are offered to senior citizens at no cost.
- Senior citizens may preview the artwork of high school students 15 minutes prior to the opening of the annual art shows on May 18 and 25.
- Senior citizens may purchase hairstyling and manicure services at a discounted cost at the Gerald R. Claps Career and Technical Center.

Questions & Answers

Q: What propositions will the community vote on at the polls?

A: This year, the community will vote on three propositions, as well as the individual Board member elections for the school district and library: Proposition 1 – Levittown UFSD 2016-2017 Budget Proposition 2 – Expenditure of Capital Reserve Funds (at no cost to the taxpayer)

Proposition 3 – Levittown Public Library Budget

Q: What is Proposition 2? Will it increase my taxes?

- A: In addition to the district's proposed budget, the community will be asked to approve a second proposition to allow the district to expend \$4 million from the capital reserve fund, previously established by voters, to undertake and perform school district improvement projects. These projects will include electrical upgrades, masonry, a playground at Abbey Lane Elementary School, weight and locker rooms at Division Avenue High School, and districtwide cooling stations. The expenditure of funds from the Capital Reserve Fund has no impact on the tax levy.
- Q: Why does the increase in the tax levy cap vary from district to district and is not a consistent limit for all levels of government?
- A: Each district must complete a tax levy worksheet based upon a formula provided by New York State to calculate its individual tax levy cap. Factors that impact the cap calculation include the tax base growth factor, received PILOT payments, debt service for capital projects and other exemptions, which vary among districts.
- Q: What happens if the 2016-2017 proposed budget is defeated at the polls?
- A: If defeated, school districts have the option of putting the same or a revised budget up for a revote, or adopting a contingency budget. If a proposed budget is defeated twice, a contingency budget must be adopted. State law mandates that if a district is forced to adopt a contingency budget, the tax levy increase over the current year is capped at zero percent.

Q: Where can I acquire more information about the district's proposed budget?

Parents are encouraged to bring their children to the voting center after school until 8 p.m. to experience the voting process together. Student votes will be tallied and results will be announced at each building on May 18.

VOTER INFORMATION

Qualifications for Voting

A voter will be entitled to vote for the election of school district trustees and the school budget, who has the following qualifications: a citizen of the United States, 18 years or older, a resident of the district for a period of 30 days or more before the election, and anyone who voted in a school, state or national election during the four years prior to the pending election. Those not registered or who have not voted in four years must register to vote before **Thursday, May 12, 2016**.

Registration forms for school elections may be obtained from the district clerk's office at Levittown Memorial Education Center.

Absentee Ballots

You must be a registered voter in order to vote by absentee ballot. Absentee ballot applications are available in the office of the district clerk on any school day between 8 a.m. and 1 p.m. Completed applications must be received by the district clerk by mail (Tuesday, May 10) or in person (Monday, May 16). Applicants can download an application from the school district website at **www.levittownschools.com**. Applications may not be submitted electronically because an original signature is required.

Upon receipt, your application will be reviewed, pursuant to the provisions of the education law, to establish your entitlement to vote by absentee ballot. A ballot will then be issued to you. For more information, contact the district clerk at 516-424-7002.
