II. NEW BUSINESS: ACTION ITEMS

2. MOTION: Mr. Porrazzo moved, "RESOLVED, that the Levittown Board of Education does, hereby, adopt a school district budget authorizing a total expenditure of \$ 189,996,581 and an associated tax levy of \$ 127,366,353, for the 2012-2013 school year, said budget to be presented to the voters of the District on May 15, 2012; and

RESOLUTION #11-12-177 Adoption of 2012-2013 Budget for May 15, 2012 Annual Vote.

BE IT FURTHER RESOLVED, that at least fourteen days before the 15th day of May, 2012, copies of the aforesaid mentioned budget shall be prepared and made available, upon request, at the office of the Superintendent, and at offices of the Principals in all the schools of the District."

NOTE: Mr. Pappas commented that tax levy percentage is not mentioned in the motion but it is 1.85%.

Mr. Flower noted that it will be in the property tax report card that is mailed out six day prior to the budget vote.

Dr. Grossane reported that it will also be in the district newsletter on the budget.

Mr. Moran remarked that he has been on the Board for 12 years and wanted to commend Central Office and the Board of Education for putting together such as great budget this year. He stated this is one of the best budgets, he has ever been involved in.

Mr. Pappas thanked the Board, Central Office and especially Dr. Grossane for coming up with a budget that reduces expenditures, provides an extremely low tax increase, but at the same time not only maintains programs but improves many aspects of our students education.

Mr. Ward asked if it was possible to state what would be the average tax increase per household in the Newsletter. Dr. Grossane responded yes it would be included and that it would even explain how to calculate the cap.

MOTION CARRIED. Seven members present voting yes.
