PROPOSITION NO. 1: 'BE IT RESOLVED, that the School District budget for the school year 2013-2014 proposed by the Levittown Board of Education, in accordance with Section 1716 of the Education Law and on file with the District Clerk, shall be approved and the necessary taxes be levied therefor on the taxable real property of the District'

PROPOSITION NO. 2: 'BE IT RESOLVED, that the Board of Education of the Levittown Union Free School District is hereby authorized, pursuant to Section 3651(1) of the Education Law, to establish the 2013 Capital Reserve Fund for the purpose of financing District-wide capital improvements including site work, construction, reconstruction, renovation and equipping of school buildings and facilities, with the ultimate amount of the 2013 Capital Reserve Fund to be \$25,000,000, the probable term to be ten (10) years and the source of the funding to be (i) amounts from budgetary appropriations from time to time, and (ii) unappropriated fund balance made available by the Board of Education from time to time, and (iii) authorized transfers from other available reserves in accordance with existing law, and (iv) New York State aid received and made available by the Board of Education from time to time.'
