- Comments and Reports Several Board of Education members attended the NYSSBA Convention in Syracuse. Ms. Adrian attended and remarked that the convention was very well rounded and it was great to see everyone back in person. She attended the keynote presentation by Actress Marlee Matlin who is hearing impaired. She gave a very motivating speech about her path to success and how her community rallied around her and her family. Mr. Pappas attended and noted that the presentation called "Building Character Achievement through Compassion for Animals", which was unbelievable, reading a story about how caring for animals leads to learning about compassion for others. RE: frog dissection which is sometimes required, there are options including using SYNFROGS, a digital version of dissection. Treat an animal well, you treat everyone well. He also attended an Electric Bus seminar, noting that you will not be able to sell a gas bus by 2027 and you will not be allowed to operate a gas/diesel bus by 2035. Not sure how this will be accomplished but right now, the infrastructure is not in place, which was also commented on by Mr. Moran who also attended and agreed that the plan doesn't take into consideration the travel distance for trips on an electric charge. Student Liaison from Division, Chris Evans: After a rousing performance at the Newsday Marching Band Festival on October 20th, the Division Avenue HS Marching band headed to Syracuse, ranked first in the state in their division, to compete at the New York State Field Band Conference at the Carrier Dome at Syracuse University. The Marching Band held on to their lead with a score of 88.4 beating the competition by 3 points to win their first ever New York State Championship in the Small Schools 3 Division. Due to illness, Division Avenue 11th and 12th graders as well as faculty and staff members who were set to participate in Challenge Day from 10/17-10/20. Challenge Day is a social-emotional wellness program that focuses

on building empathy and compassion. Unfortunately, the Challenge Day staff facilitator fell ill and the program will have to be rescheduled. On Wednesday, October 26th, we had our Volleyball Dig Pink event. The Girls Varsity Volleyball Team and staff members competed in a very intense volleyball game. Raffles, food, and shirts were sold to help raise money for breast cancer research. All proceeds were donated to The Side-Out Foundation. The faculty and staff team were unable to defend their title against a very formidable girls Volleyball team. Everyone is already looking forward to the game next year! Peer Pals hosted a Halloween dance for our Career Development students on October 28th at 6:00 PM. The night was filled with dancing, singing, games, pizza and snacks, and awesome costumes. The November food drive is underway with all of the classes competing for a good cause. It is one of the biggest events in the Spirit competition and it also accounts for a huge contribution to the Wisdom Lane Food Pantry. Last year we provided Thanksgiving meals to more than 30 Division Avenue families and filled an entire truck with food for the food pantry. Division Guidance presented several important events such as Financial Aid night, PSAT testing, "Meet Your Counselor Night" and meeting with seniors to submit their College applications, meeting the November 1 deadline to colleges. The Levittown District Girls Varsity High School Swim and Dive Team are the 2022 Conference 3 Champions. The team ended their dual meet season with a perfect 8-0 record. This was Levittown District's second Conference Championship in the last four years. The girls soccer team advanced to the playoffs, losing a very close first round game. On November 10th 2 Division Avenue High School Student-Athletes will be signing National Letters of Intent to continue playing their sport at the Collegiate level. Joseph Yovino will be signing to play Division 1 Baseball for Elon University and Olivia Agunzo will be signing to play Basketball at St. Leo University. Congratulations to the Varsity

Cheerleading team who won the NY State GameDay East Invitational Championship beating 11 other finalists from the Class C Division including Bethpage, Wantagh and Plainedge. This month students in all grades will participate in assemblies covering a range of topics
