SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. The District developed a multi-process for stakeholders to give meaningful feedback about the utilization of the ARP funds. Secondary level buildings had meetings with student groups to collect their feedback. This information was shared with the district level stakeholder committee which consisted of representatives from collective bargaining units, administrators, teachers, parents and community members. This committee met multiple times through zoom to review the student feedback and create a prioritized list. This information was then reviewed by district administration and our Board of Education. The final plan was posted on the district website for additional community feedback. This stakeholder committee will continue to meet quarterly each year to review the approval status of the grant, and to review the progress of implementation. Updates will be shared with the community via the Levittown District website.

In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.

The majority of grant funds have been utilized to address learning loss due to COVID19. Some funds have been allocated to improve classroom ventilation. Classroom ventilation is a major component of the CDC reopening guidance. CDC recommends a layered approach to reduce exposures to SARS-CoV-2, the virus that causes COVID-19. This approach includes using multiple mitigation strategies, including improvements to building ventilation, to reduce the spread of disease and lower the risk of exposure. Ventilation system upgrades or improvements can increase the delivery of clean air and dilute potential contaminants. The addition of wall air conditioners will allow for a slight increase in room air filtration based on the inclusion of units with MERV-rated filtration. There is continuous maintenance and monitoring of the ventilation and airconditioning systems.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

The district will utilize a variety of data sets to monitor student progress. We will utilize our iReady scores in grades K-8, AIMSWEB in gr K-5, state assessment scores (where applicable), marking period grades, and teacher feedback. Data from iReady will be utilized to identify the specific domains that present as deficits to our students in grades K-8. Data from the fall benchmark indicate that phonics is an area of deficit in grades K-2. The district will be utilizing the Orton Gillingham Approach to address this need, as well as personalized learning pathways through the iReady platform.

Additional support staff will be utilized in primary grades to address phonics deficits and early numeracy deficits through the use of Fundations and First in Math programs. Morning academies will be utilized to address a wide variety of learning loss, including reading and mathematics gaps (as determined by iReady fall benchmark data) in grades K-8 and learning loss in ELA, mathematics, science and social studies in grades 9-12 (as determined by first quarter averages and teacher observation). Tutoring will be provided to targeted English Language Learners before and after school in grades K-12. Tutoring will focus on content knowledge and language support, utilizing Footsteps 2 Brilliance (K-5) and Off 2 Class (6-12).

5. The majority of our grant will be utilized to address learning loss. This will be done by expanding our use of iReady for instructional support, adding an additional specialized reading program, adding support staff for elementary students, providing morning academies (tutoring) for students in grades K-5 and tutoring for English Language Learners in grades K-12.

The district intends to use the remaining fund in a way consistent with this first phase. Funds will be used to expand summer school, add mental health staff, add additional social emotional programming (Responsive Classroom), implement small group instruction in grades 3-5, and provide additional teachers for math support in grades 7-12.

Interventions are included in the ARP submission to support the needs of students particularly affected by learning loss such as tutoring for English Language Learners and the specialized reading program for students with disabilities. The district will be implementing morning and afternoon academies to address reading and math deficiencies in grades K-8 and deficits in ELA, mathematics, science and social studies in grades 9-12. These academies will be open to all students, but will specifically target students identified as having deficiencies using the iReady fall benchmark data. This will include students from low-income families, students of color, students experiencing homelessness, children in foster care, and migratory students. Staff members in the school counseling department and ENL department will make regular contact with families of students from the disproportionately affected groups previously identified. This will ensure that our wrap around services are provided to those in greatest need. Additional mental health staff are incorporated in our ARP State Reserves application. Mental health staff members have been (and will continue) pushing into all classrooms in the district to speak with students and identify those who have specific SEL/mental health needs. Those needs are/will be addressed through individual and group counseling sessions. The district will also be implementing Responsive Classroom (research based SEL program) in K-5 buildings and is part of the ARP State Reserves application.
