Dear Parents:

The Levittown/Island Trees Youth Council in cooperation with the Levittown School District will again offer the popular five-week summer recreation program with the cost of \$325.00 per child.

The Summer Recreation Program will provide elementary youngsters presently in Grades K-5 with a Recreation Program from 9:00 A.M. to 12 Noon every weekday from June 28 through July 30, 2021. The program will take place at the Levittown Memorial Education Center. Supervised activities such as knock hockey, basketball, outdoor games, as well as arts and crafts will be offered.

**A minimum of 225 registered youngsters is necessary to run the Summer Recreation Program.** Therefore, a completed registration form accompanied by a \$200 deposit is necessary and must be postmarked **no later than Friday June 18, 2021.** The tuition balance of \$125 will be required on the first day of the program, **Monday, June 28<sup>th</sup>.**
