Dear Parents/Guardians,

This year's end of the year celebration sponsored by Salk's Student Council will be an exclusive outing at Adventureland in Farmingdale on Tuesday, June 4th from 5:30-8:30 p.m. The cost of the trip will be \$40.00 per student. The cost of admission covers an exclusive outing for Salk students ONLY, rides, and faculty supervision. If students wish to purchase food, souvenirs or play other games at the park- they must bring their own money.

Adventureland is Long Island's Amusement Park since 1962 and we welcome your child to come and enjoy a fun filled evening on their rides, attractions, games and more. We will follow any park rules that Adventureland has in place as well as rules set forth from Jonas E. Salk MS for the entire event. Please see Adventureland's website for any additional information.

This is a drop off and pick up event for Salk students **only**. Students will be dropped off at the rear entrance of the park NO earlier than 5:30 p.m. Students **MUST** be wearing their admission bracelet to enter. Bracelets will be handed out at school that day. Any student who loses their bracelet will be required to purchase a new one at the park. If your bracelet breaks you must return it to group sales for a replacement. Bracelets are treated like cash so please be careful. All students must be picked up promptly at 8:30 p.m. Please be aware that students will be permitted to leave the park **on their own** at dismissal. It is up to **parents and students** to coordinate a pick up location. If you **DO NOT** want your child released from the park you may enter at 8:20 p.m. Please be aware that we will **NOT** be monitoring this. Your child is responsible for remaining in the park until a grown up comes in to get them, if that is the arrangement you make with the student.

All other students will be dismissed w/o an adult.
