The 7th grade science classes will be attending a field trip to the Sunken Forest at Sailors Haven on Fire Island. Mr. Zaratin and Mrs. Tomeo's classes will attend on **Thursday, October 5th**. Mrs. Arty, Ms. Bleimeyer and Mrs. Maloney's classes will attend on **Friday, October 6th**. The cost of the trip will be **\$38.00** per student to cover the cost of the bus and ferry ride to and from Fire Island. We will **leave** Salk at **8:15 a.m.** and will take the 9:30 ferry out of Sayville. We should be at Sailors' Haven by 10:00 a.m. We will return to Sayville on the 1:00 p.m. ferry and should **arrive** at Salk approximately **2:55 p.m.** (traffic permitting).

Students should be prepared to be outside for the entire afternoon. Please have them dress for the weather, remembering that it is usually cooler at the beach than in Levittown. There is **no cafeteria** at Sailors' Haven, so students will need to **bring their own PEANUT/TREE NUT FREE lunch**. There are restroom facilities in a few locations throughout our tour of the forest.
