The 7th grade science classes will be attending a field trip to the Sunken Forest at Sailors’ Haven on Fire Island. Mrs. Going, Mrs. Halvorsen and Mr. Roseval’s classes will attend on **Thursday, September 28th**. Mrs. Carlson’s classes will attend on **Friday, September 29th**. The cost of the trip will be **\$38.00** per student to cover the cost of the bus and ferry ride to and from Fire Island. We will **leave** Wisdom at **8:05 a.m.** and will take the 9:30 ferry out of Sayville. We should be at Sailors’ Haven by 10:00 a.m. We will return to Sayville on the 1:00 p.m. ferry and should **arrive** at Wisdom approximately **2:55 p.m.** (traffic permitting).

Student’s should be prepared to be outside for the entire afternoon. Please have them dress for the weather; remembering that it is usually cooler at the beach than in Levittown. There is **no cafeteria** at Sailors’ Haven, so students will need to **bring their own PEANUT/TREE NUT FREE lunch**. There are restroom facilities in a few locations throughout the tour of the forest.
